#### DAĞITIM YERLERİNE

New York Ticaret Ataşeliğimiz tarafından iletilen bir yazıda, Birleşmiş Milletler'in (BM) ihtiyaç duyduğu ürün ve hizmetlerin tedarikinin üye ülkelerin şirketlerinin katılabildiği ihale süreçleri cercevesinde BM Operasyonel Destek Birimi tarafından yürütülmekte olduğu bilgisi verilerek söz konusu birimin üye ülkelerin şirketlerinin ihale ve satın alma süreçleri, ihale sistemine kayıt olma şartları konularında bilgilendirilmesi amacıyla çeşitli ülkelerde iş semineri adı altında bilgilendirme etkinliklerinin düzenlenmekte olduğu ifade edilmektedir.

Yazıda devamla, BM Yetkilileri tarafından ülkemiz şirketlerinin katılımı ile yeni bir iş semineri düzenlenmesinin istendiği, programın çevrimiçi veya fiziki olarak yapılabileceği, birden fazla şehirde seminer düzenlenebileceği, şirket katılımının ülkemiz tercihine göre sektörel veya genel olarak değişebileceği, seminerin farklı şehirlerde olması halinde her bir şehirde en az yarım gün olacak şekilde program yapılabileceği, iki adet yarım günlük oturumlar halinde de düzenleme yapılabileceği, seminerlerde BM ihale sisteminin ve şirketlerin sisteme kayıtlarının ele alınacağı ve soru cevap oturumlarına da imkan tanındığı, farklı ülkelerde düzenlenen seminerlerde katılımcı şirket sayısının en az 25 sirket olmak üzere 100'ün üzerine çıkabildiği, bunun ev sahibi ülkece sağlanan fiziki imkanlar ile ilgili olduğu vurgulanmaktadır.

Yanı sıra, BM Yetkilileri tarafından görevli resmi makamların temsilcileri ile ticaret sanayi odası ve benzeri kuruluşların çalışanları için de aynı konularda ayrı bir eğitim verebileceği, bu eğitimlerin sirketlere kapalı olacağı, oturumların şirketlere verilen seminerlerle aynı konuları içermekle birlikte, ülke makamlarının BM ihale sistemi hakkında daha iyi bilgilendirmesinin amaçlandığı belirtilmektedir.

Bu bağlamda, etkinlik tarihinden en az 45 gün önce BM Yetkililerine bilgi verilmesi durumunda etkinliğin Türkiye'de düzenlenebileceği, alternatifli tarih önerilerinden memnuniyet duyulacağı, ev sahibi ülkeden temel beklentilerinin seminer için fiziki yer sağlanması ve şirketlere duyuru yapılması olduğu, seminerleri yürütecek BM personelinin masraflarının ise BM tarafından karşılanacağı ifade edilmektedir. Toplantı sonrası Ataşeliğimize iletilen Taslak Gündem örneği, Seminer Hazırlık ve Katılımcı Listesi taslakları ekte paylaşılmaktadır.

Bilgileri ve konuya ilişkin değerlendirmeleriniz ile uygun görülmesi halinde fiziki veya cevrimiçi eğitim seçenekleri, fiziki seminer düzenlenmesi durumunda hangi şehirlerde yapılacağına dair tercihlerin ve alternatifli tarih önerilerinin BM Tedarik Zinciri Yönetimi Birimi ile paylaşılmak üzere Bakanlığımıza iletilmesi hususunda gereğini rica ederim.
